

《光復香港 時代革命》專家報告的謬誤

香港第一宗以《國家安全法》起訴案件，核心環繞“光復香港、時代革命”口號。

控方委托劉智鵬攥寫“專家報告”（“光時報告”），企圖以其“奇特”方式詮釋該口號的兩個關鍵用詞：“光復”和“革命”。

案件已結束，被告放棄上訴，算是蓋棺定論。也慶幸法院沒有接受“專家”對兩詞的詮釋，事件也算告一段落。惟日前僥幸獲得 SOPA（亞洲出版業協會）卓越評論獎，（SOPA 獎有稱是亞洲普利茲），不妨溫故知新，以儆效尤。
